Online classes at MCCC are **NOT self-paced**. Instruction is delivered in an entirely web-based format. Students must complete exams, assignments, etc. by specified due dates. Some exams and assignments may be required to be completed at an authorized location as established by the instructor.

When taking an online class students are responsible for:

- A reliable computer with Internet access and Microsoft Word; course specific software will be described below
- Knowing how to email attachments
- Maintaining his or her own computer and Internet connection; technical issues are NOT acceptable excuses for not keeping up with due dates
- Having access to a printer if needed for personal use of online materials

It is the student's responsibility to log into Brightspace multiple times each week to keep up with communication, assignments and other coursework.

### Brightspace

Online courses use Brightspace course management system as the means of communication between the students and the instructor.

It is the student's responsibility to be able to log into Brightspace and maintain his or her computer setup to work properly with Brightspace.

COURSE DESCRIPTION	<p>This course provides students with the skills and knowledge to work in and understand the challenges managers face in an increasingly digital world. The course includes an introduction to managing activities in the digital enterprise, including how the work of managers has changed as more employees and customers migrate to online. The hands-on portion of the course will include suite software, e-commerce, digital communications, (including mobile devices), the Internet, email and other networked resources used to turn data into commercial information. REGISTRATION PROCESS	<p>Students must register for the course through the College's regular registration process.</p> <p>If you are a first-time online student at MCCC you must complete an online orientation course (ONL-001). You will be automatically enrolled into the online orientation course, which will provide you with critical information on the technical, study, reading and writing skills necessary to be a successful online student. This course will be listed in your MyCourses module in Brightspace and there will be 4 modules to complete. Please note that all four modules will NOT be visible when you first login, but will become visible once you complete the requirements for each module. Please complete <b>FL2019-ONL-001-L1 by August 23, 2019</b>. Failure to complete the online orientation by the above date may result in <u>de-registration from your Fall 2019 online course</u>.</p>
PROCTORED EXAMS OR ASSIGNMENTS	None, all coursework is completed online.
ADDITIONAL INFORMATION: PROCTORED EXAMS OR ASSIGNMENTS	<p><b>Some</b> online classes require students to take exams at authorized, proctored locations. Test proctoring centers are authorized testing locations where a staff person administers a test or assignment. If students are not able to arrange transportation to MCCC's main campus for testing, a proctored test site must be arranged. Students near the MCCC campus can take the test in the Regional Computer Technology Center (RCTC). It is the student's responsibility to make arrangements for proctoring with his or her instructor. <p>COURSE EXPECTATIONS</p>	<p>This course uses Microsoft’s Office 2016 or Office 365 software, including ACCESS. You need to have it on the computer you will be using or have access to it. Your MCCC email address allows you to access the complete Microsoft Office 2016 package of software if you do not already have it.</p> <p>Some keyboarding proficiency is necessary. “Two finger” keyboarding will present a significant limitation to the student. Familiarity with the Windows 7, Windows 8, or Windows 10 operating systems, web browsers, and email software (including how to attach multiple files), are necessary ‘pre-skills’ for this online course. The websites used are configured to function with Apple systems as well. Microsoft Office products for Mac’s are not always of the same version as those available for PC’s and present some challenges for completing Office 2016/Office 365 assignments. <b>There is no ACCESS (data bases) software for Mac’s.</b></p> <p>There is a high volume of homework associated with this course, with multiple assignments per week. Learning activities will include textbook and online readings, slide presentations, web resources, web-based activities including threaded discussions, assignments that will be submitted online, online assessments, and online examinations. The Brightspace course management system, MCCC email, and publishers’ websites like McGraw-Hill’s <i>Connect</i> and McGraw-Hill’s <i>SimNet</i> will be the primary tools for homework and examinations.</p> <p>Most assignments and documents will become available when the course opens and must be submitted by 11:59 p.m. on a given date, usually—but not always—on Sunday evening. These dates are detailed in the course schedule that will be available in the Syllabus &amp; Schedule section of Brightspace.</p> <p>Online exams will be given. Dates for the exams will be posted in the Syllabus &amp; Schedule and Course Documents section of Brightspace. Typically, students will be able to take the exams after completing the associated chapter assignments. The exams will be timed with the submission time ending at 11:59 p.m. on the due date.</p> <p>There will be <b>no make-up exams</b> except in the case of a documented medical emergency and the Instructor’s permission. You will get three “attempts” for each exam in the event that you encounter technology related issues. Your highest score will be used in grade calculations.</p> <p>There will be deadlines for projects and/or assignments <b>to be submitted in the Assignments (Content and Activities) area of Brightspace, McGraw-Hill’s Connect, or McGraw-Hill’s SimNet. All assignments are open and available as the course opens. There are no extension options.</b> With few limitations, you will be permitted to work ahead.</p> <p>In addition to the course site on Brightspace, you will be using publishers’ companion websites where much of your work will be completed. There will be other course resources on the Internet that you will need to access during the semester.</p>

Students must have access to a computer with authorized copies of the Microsoft Office 2016 Suite of programs: WORD, EXCEL, ACCESS, and POWERPOINT. NOTE: Most student versions of Office **DO NOT** come with ACCESS. While there are attractive purchase options for you to acquire the entire suite because of your student status, if you are able to use MCCC’s labs or other labs, please do so to avoid purchasing only ACCESS—if you are unlikely to use it in the future. The materials for the course are available to you by using your MCCC email address to download them at no cost to you! **A Mac NOTE: There is currently no version of ACCESS that works on a Mac and some of the commands for EXCEL are different for a Mac.** Details will be provided early in the course on downloading.

You will benefit from an Internet connection that can support downloading and playing of videos and uploading and downloading of large files. **NOTE: Office 2016 will require Windows 7 or Windows 8 or Windows 10.**

The course will become “available” on the first day of the semester. You need to access it early to get off to a successful beginning in the course. There will be assignments due right after the semester commences. You will need the text materials (which can be eVersions of the texts) and

access codes to Connect and SimNet when the semester opens—any delay will impede your success in the course. These McGraw-Hill sites provide for a temporary access to get started on time.

It is the student’s responsibility to learn how to navigate the Brightspace course site. There are online orientation materials for Brightspace on the MCCC website.

All students who have officially enrolled will have full access to all areas of the Brightspace course site no later than **Wednesday, August 28, 2019**. When you access the course you will see a tab labeled “START HERE.”
